How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

1832 Asset Management L.P. has rated this Fund's risk to be high.

This rating considers how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

How has the Fund performed?

This chart shows how the Series F shares of the Fund have performed in each of the past 10 calendar years. The Fund dropped in value in 4 of the past 10 calendar years. How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F shares of the Fund. The fees and expenses, including any commissions, can vary among series of the Fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

No sales charges are applicable to the Series F shares of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the Series F shares of the Fund.

As of June 30, 2024, the Series F shares of the Fund's expenses were 1.45% of its value, which equals \$14.50 for every \$1,000 invested.

The Fund may pay 1832 Asset Management L.P. a performance fee based on the Fund's out-performance versus the following reference indices: 75% S&P/TSX Capped Energy Index; and 25% MSCI World Energy Index (C\$). Any performance fee payable is calculated as described in the simplified prospectus to a maximum of 2.00% of the average month-end net asset value of the Fund during the calendar year. The performance fee is estimated and accrued daily, calculated at calendar year-end using the average month-end net asset value and is paid within thirty days after calendar year-end. As of June 30, 2024, the Fund did not accrue any performance fees.

3. Other fees

You may have to pay other fees when you buy, hold, switch, redeem or reclassify shares of the Fund.

What you pay
This fee is negotiated with and paid to your representative's firm to a maximum of 2% of the value of shares you switch to another fund.
If you redeem or switch securities within 30 days of purchase or switch we may charge a short-term trading fee of 1% of the prior business day net asset value of the securities you redeem or switch.
You may pay a fee, which is negotiated between you and your representative and paid directly to your representative's firm. Investors who purchase Series F shares of the Fund must participate in an eligible fee-based or wrap program with their representative's firm.
