1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Dynamic Active U.S. Dividend ETF.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

#### Investment Objective and Strategies

The Fund seeks to provide interest income and the potential for some long-term capital growth by investing primarily in North American fixed income corporate securities that are rated close to the line dividing investment grade and high-yield credit.

Exposure to these types of fixed income securities will be obtained by investing primarily in Dynamic Active Crossover Bond Fund (the "Underlying Fund"), and/or by investing directly in them, in securities of one or more Other Funds, and/or through the use of derivatives.

#### Risk

The risks associated with investing in the Fund are as described in the prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

#### Results of Operations

For the year ended December 31, 2023 (the "period"), the Fund generated a total return of 8.4%. Fund returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, the S&P 500 Index (C\$), returned 23.2% during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general performance of the market.

The Fund underperformed the benchmark primarily due to stock selection in the Information Technology sector along with overweight exposure and stock selection in the Industrials sector. The underperformance occurred in the first half of the year. During the latter half of the year, the Fund outperformed the benchmark. The Fund's significant underweight exposure to the Consumer Staples sector was a key positive for relative performance.

The U.S. equity market ended the 12-month period in positive territory as the S&P 500 Index (C\$) returned 23.2%. In 2023, we saw the U.S. Federal Reserve (Fed) ease the foot off the accelerator and raised interest rates only four times this year versus seven interest rate hikes in 2022. The rate hikes over the last couple of years had a positive impact in taming inflation. Inflation fell from 6.4% at the start of the year to 3.1% in November, inching closer to the Fed's target rate of 2%.

The single most important factor standing in the way of lower inflation and hitting the Fed's target rate is shelter costs, which includes housing and rentals. Shelter inflation rose 6.5% in November and accounts for about 30% of the Consumer Price Index (CPI). CPI is used to measure inflation. Excluding shelter, inflation would have been just 1.4% – well below the Fed's 2% inflation target. Fed Chairman Powell indicated that the central bank was aware of the risk of keeping interest rates at restrictive levels for too long. Powell added, 'You wouldn't wait to get to 2% [inflation] to cut rates. It would be too late.'

Equity markets registered strong gains in the final quarter by expectations that interest rate cuts may be approaching in 2024. As such, the S&P 500 Index (C\$) returned 9.8% in final quarter. The U.S. economic outlook has also brightened in recent months as healed supply chains and an influx of workers into the labour force are curbing wage and price increases without causing broad economic weakness.

Seven of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 12-month period. The best performing sectors were Information Technology, Communication Services and Consumer Discretionary. The worst performing sectors were Utilities, Energy and Consumer Staples.

Over the period, the U.S. dollar strengthened against the Japanese yen, while weakening against Canadian dollar, Euro currency and the British pound.

At period end, the Fund was comprised of seven of the eleven sectors of the S&P 500 Index (C\$). If we do not like companies in a particular sector, we will zero weight the sector.

The Fund's holdings from the Information Technology sector were by far the biggest sector contributors to performance, however, they underperformed those of the benchmark. Early in the first quarter of the year, our Information Technology weighting was low as the sector had a difficult year in 2022, and we acted accordingly. In January of this year, mega cap technology

companies had a very strong performance period, and although we added to our weighting in the sector and were overweight by the end of the quarter, the benchmark's Information Technology stocks had a lead on ours in terms of returns. The Fund did not own Apple as it did not meet our investment criteria and Apple was the second-best contributor to benchmark performance. Also, Information Technology company Arista Networks was the second biggest stock detractor from Fund performance, and it was not a notable detractor from benchmark performance primarily because of its small weighting in the benchmark. The Industrials sector is an area where we continue to find opportunities. However, during 2023, the Fund's overweight to the sector detracted from relative performance. The Industrials sector was a positive contributor to benchmark performance, but the contributions by other sectors to benchmark performance were much larger. The Fund's Industrials sector holdings were positive contributors to performance but were outperformed by those of the benchmark. Five of the Fund's top ten detractors were from the sector. Those positions were exited by period end.

The Consumer Staples sector was one of four sectors to detract from benchmark performance; thus, the Fund's significant underweight versus the benchmark was a key positive for relative performance. The Fund only held one company from the sector, and it was a positive contributor to Fund performance. The position was exited by period end.

Notable changes to the Fund's sector allocation during the past twelve months were an increase in the Information Technology and Communication Services sector weightings and a decrease in the Health Care and Financials sector weightings. Changes to sector allocations are the result of the bottom-up investment process.

The Fund's net asset value decrease to \$124.7 million at December 31, 2023, from \$153.3 million at December 31, 2022. This change was composed of net redemptions of -\$38.2 million and investment performance of \$9.6 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

The Fund may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions exceeds the portion of net income and net realized capital gains, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

## Recent Developments

There have been no recent developments that have affected, or likely to materially affect the Fund.

## Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia

Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a “related party”). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm’s length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

### **Management Fees**

The Manager is responsible for the day-to-day management and operations of the Fund. The Fund pays the Manager a management fee for its services as described in the “Management Fee” section later in this document. The management fee is an annualized rate based on the net asset value of the Fund, accrued and calculated daily and paid monthly.

### **Operating Expenses**

The Fund is responsible for fees and expenses incurred in complying with NI 81-107, including the fees payable and expenses reimbursed to members of the Independent Review Committee, brokerage expenses and commissions, fees relating to the usage of derivatives, income tax, harmonized sales tax (“HST”), withholding and other taxes.

Apart from the initial organizational costs of the Fund, all expenses related to the issuance of units of the Fund shall be borne by the Fund unless otherwise waived or reimbursed by the Manager. Further details about the Fund’s operating expenses can be found in the Fund’s most recent prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of the Fund’s operating expenses. These waivers or absorptions may be terminated at any time without notice.

### **Independent Review Committee**

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions

require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the

Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

## Management Fees

The management fee is an annualized rate based on the net asset value of the Fund, accrued and calculated daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution

of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

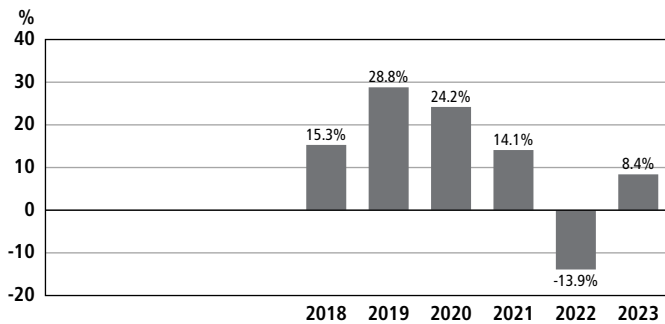
