1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Dynamic Dividend Income Fund.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended at December 31, 2020 (the "period"), the Series A units of the Fund generated a total return of 5.4%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmarks, the S&P/TSX Composite Index and the FTSE Canada Universe Bond Index returned 14.1% and 1.1%, respectively, during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general performance of the market,

but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 50% S&P/TSX Composite Index and 50% FTSE Canada Universe Bond Index, returned 7.6% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

The Fund underperformed the blended benchmark due to security selection and an underweight in Financials and Industrials and an elevated cash position.

The Canadian and U.S. equity markets ended the 6-month period in positive territory as the S&P/TSX Composite Index returned 14.1% and the S&P 500 Index (C\$) returned 14.4%. The second half of the year saw both indices surge to new market highs after a tumultuous first half as the pandemic spread of COVID-19 created a nationwide lockdown earlier in the year.

In Canada after two contracting GDP quarters, the third quarter saw GDP grow by an annualized rate of 40.5% as the economy began to re-open. As well, crude oil prices rallied and stabilized in the \$40-\$50 (U.S. dollar) per barrel range after collapsing in the first half of the year as a result of the pandemic. Stronger demand began late in the year, offsetting concerns over increased supply in crude oil. The extremely low interest rate environment boosted the housing market. Both monetary and fiscal policies remained supportive throughout the year and are expected to continue into 2021. The road to recovery is still very much impacted by the pandemic.

The U.S. economy recuperated in the third quarter as business activities re-opened along with the U.S. Federal Reserve (Fed) reiterating their stance on maintaining low interest rates, even allowing inflation to float above 2% before raising rates. The market, especially economically sensitive sectors, reacted very positively.

Entering the final quarter of 2020, the U.S. had a contested presidential election and a second wave of COVID-19. Yet through this period, U.S. equity markets remained resilient, being buoyed by the expectations of the Food and Drug Administration approving a safe and effective COVID-19 vaccine. By year-end, a sense of optimism for investors had been regained as vaccine rollout was scheduled for early 2021.

In Canada, all 11 GICS sectors posted positive returns over the 6-month period. The best performing sectors were Consumer Discretionary (+31.2%), Industrials (+21.6%) and Financials (+21.3%). The worst performing sectors were Consumer Staples (+3.0%), Materials (+5.1%) and Energy (+5.4%).

In the U.S., ten of the 11 GICS sectors posted positive returns over the 6-month period. The best performing sectors were Industrials (+22.0%), Materials (+21.6%) and Financials (+20.7%). The worst performing sectors were Energy (-3.8%), Real Estate (+0.3%) and Utilities (+6.1%).

Over the period, the Canadian dollar was mixed against the major currencies. It strengthened against the U.S. dollar and the Japanese yen, while it weakened against the euro and the British pound. The U.S. dollar weakened against most major currencies, including the Canadian dollar, the euro, the British pound and the Japanese yen.

The Canadian bond market, as represented by the FTSE Canada Universe Bond Index, was up 1.1% for the six-month period ending December 31, 2020. The 10-year Government of Canada yield began the period at 0.53%, fell to a low of 0.43% in August, before slowly moving higher and finishing the year at 0.68%. The Bank of Canada (BoC) made no rate cuts in the second half of the year.

Within the U.S., the 10-year Treasury fell to a low of 0.51% in August before finishing the period at 0.92%. The U.S. Federal Reserve kept its benchmark interest rate unchanged at 0.25%. As the pandemic continued the chairman of the Fed, Jerome Powell announced a policy shift with a move to average inflation targeting, meaning that the central bank would be more inclined to allow inflation to increase in the future.

Investment grade and high yield credit spreads, as measured by ICE BofAML Canadian and U.S. credit indices OAS, continued to rally in the second half of the year, further fueled by 4th quarter vaccine news and the resolution of political uncertainty in the U.S. Towards the end of the year, the U.S. Treasury announced the effective cancellation of several credit facilities they had implemented for emergency lending purposes. Reactions to the announcement were muted and North American investment grade spreads continued their retracement to near pre-pandemic levels by the end of December.

The Fund maintained an overweight in equities (which includes REITs and options) and an underweight in bonds. Over the period equities were increased with bonds seeing a corresponding decrease as the level of cash was unchanged. Among equities, the options component which provided attractive premiums was lowered as exposure is opportunistically dependent. Geographically the Fund remains biased to North America though the allocation to the U.S. rose significantly as Canada was decreased. Both Canada and the U.S. were positive contributors to returns with the U.S. having the greater impact on performance.

The Fund's bond allocation increased in relation to the 1832 AM U.S. \$ Investment Grade U.S. Corporate Bond Pool while positions in Dynamic Total Return Bond Fund and the 1832 AM Investment Grade Canadian Corporate Bond Pool were reduced. The exposure to foreign bonds was maintained and the weighting in Federal government bonds was lowered. Overall, the fixed income component was a modest positive contributor.

Among equities the largest sector weightings were in Financials, Information Technology and Utilities. These three sectors were also the most notable positive contributors to performance with holdings in Materials and Energy detractors. Over the period the allocation to cyclicals, primarily through Financials, Industrials

and Information Technology, was increased as Utilities were lowered. Currency hedging undertaken had a positive impact. Individual security detractors included Starwood Global Opportunity Fund and the 1832 AM U.S. \$ Investment Grade U.S. Corporate Bond Pool while Innergex Renewable Energy and JP Morgan Chase & Co. were significant contributors to returns.

The Fund's net asset value decreased to \$427.7 million at December 31, 2020, from \$428.2 million at June 30, 2020. This change was composed of net redemptions of \$22.6 million, cash distributions of \$1.4 million and investment performance of \$23.5 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

COVID-19

The spread of the COVID-19 virus began in late 2019 and led to a subsequent and dramatic global shutdown by March 2020 of all but the most essential activities. Many businesses and schools were closed along with borders as mobility restrictions were put in place around the world. This generated significant headwinds for corporate and consumer income which led to an increase in financial market volatility. In late March, markets began to see a dramatic reversal with investors encouraged by the amount of stimulus being introduced into the financial system by global policy makers. Trillions of dollars of supplementary income, tax relief, and lending backstops were put into place. The recovery continued throughout the course of 2020 with many markets seeing sharp recoveries, although not all sectors and industries participated in the recovery with sectors such as travel, energy and real estate continuing to lag. A globally coordinated approach to vaccine development continued throughout the second half of the year with Pfizer and Moderna both developing and starting to distribute a vaccine in record time. The rollout of the vaccine progressed around the world through the end of 2020 which continued to buoy markets. For now, we continue to monitor the situation and the effects on the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer,

and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$4,000 in commissions to Related Brokers.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager may also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steve Donald, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The main components of

compensation are an annual retainer and a fee for each committee meeting attended. The chair of the IRC is entitled to an additional fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fee

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

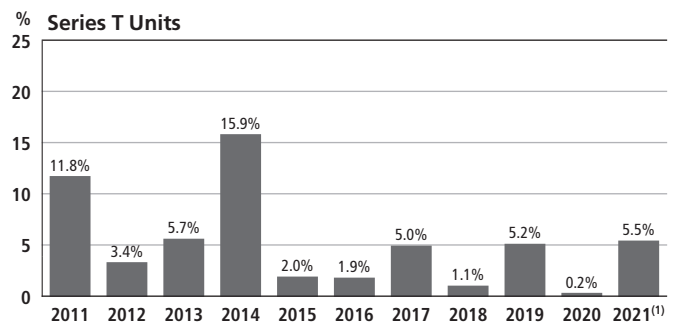
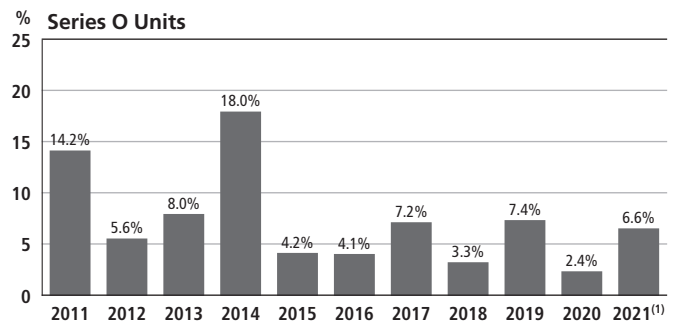
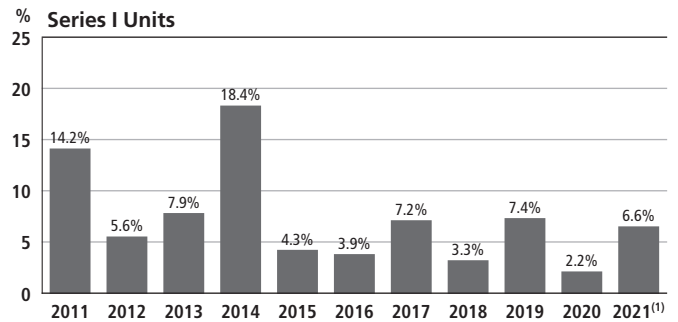
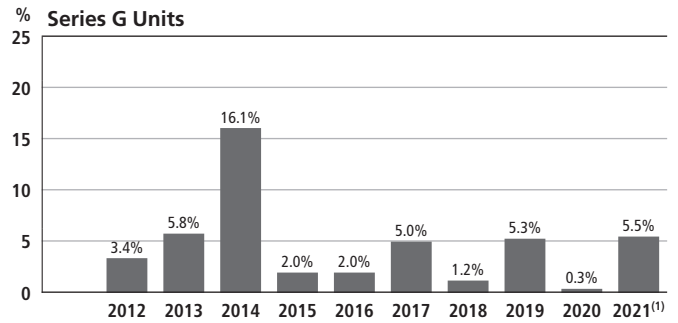
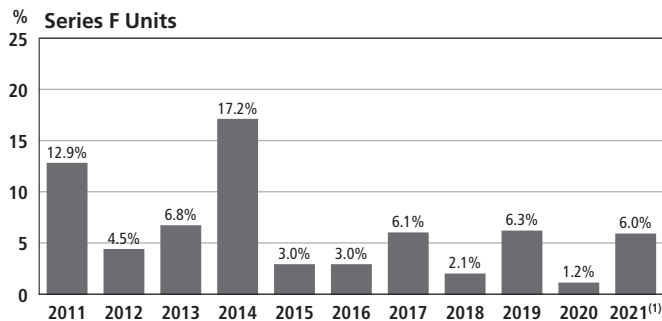
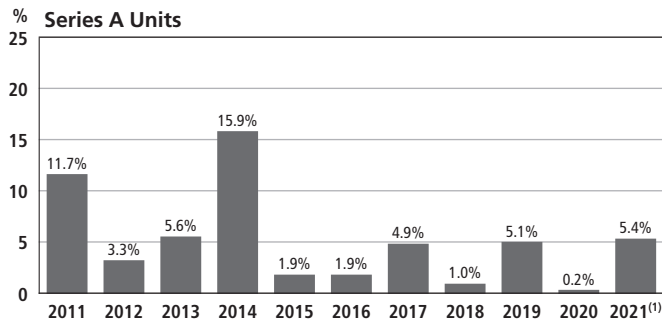
Past Performance
